1. The Statutory Auditors have carried out limited review of the above results and the same have been reviewed by the Audit Committee and taken on record by the Board of Directors at its meeting held on 13th November 2010.
2. The current accounting year of the Company has been extended by a period of 3 (Three) months. As such, the current accounting year shall be a period of 15 (Fifteen) months beginning on 01st October, 2009 and ending on 31st December, 2010. The subsequent accounting years, as such, shall begin on 01st January and will end on the following 31st December every year.
3. Tax Expenses includes Provision for Current Tax and Deferred Tax.
4. The Company has only one segment viz. 'Consumer electronics and components/parts thereof' as per Accounting Standard on Segment Reporting (AS) -17 of ICAI.
5. During the quarter ended 30th September 2010, 24 investors complaints were received and resolved. There were no investor complaints pending at the beginning of the quarter and at the end of the quarter.
